


Public Company Stock Performance – Twelve Months Ending December 31, 2021





RELATIVE SUBSECTOR STOCK PERFORMANCE



FOOD & BEVERAGE COMMODITY PRICING TRENDS






NATURAL FOOD & BEVERAGE FINANCING VOLUME





