



RELATIVE SUBSECTOR STOCK PERFORMANCE










Natural Food & Beverage Transaction Mix by Subsector - North America Targets









Pernod Ricard acquired a majority stake in Skrewball, which joins the company's lineup of well-known brands that include Jameson Irish Whiskey and Absolut Vodka.
